**NOTICE TO INDUSTRY**

**SUBJECT: TEMPORARY INTERIM WAGE INCREASE**

At a meeting of the Full Council held on 4<sup>th</sup> September 2021, parties agreed to the following:

1. As of the date of this meeting, an agreement on wages was not settled.
2. Therefore, as a way of facilitating processing of the September 2021 payrolls by companies as they come due and while pending finalization of the 3<sup>rd</sup> Quarter Wage negotiations, a temporary Interim Wage increase of 5.128% be implemented across all grades as from 1<sup>st</sup> September 2021.
3. This temporary Interim Increase will bring the A1 Grade to ZWL20 500.00.
4. Minimum wage levels for the rest of the grades are stipulated on the attached schedule.
5. NEC dues are to be calculated based on the new interim minimums.

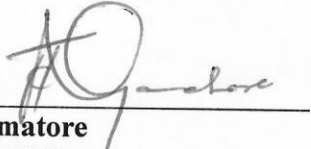
