**NOTICE**

**TO ALL EMPLOYERS AND EMPLOYEES**

**RE: WAGE AGREEMENT: GENERAL ENGINEERING SECTION (SKILLED  
WORKERS AND GRADED JOB CATEGORIES OF EMPLOYEES)**

---

Please be advised that:

1. Notwithstanding the date of signature or publication hereof, this agreement of basic minimum wage, shall be deemed to have come into operation on 1<sup>st</sup> of June 2023.
2. Parties have agreed to 8.333333% wages increments on NEC basic wage/salary minimums across all grades for period 1<sup>st</sup> of June 2023 to 31<sup>st</sup> August 2023.
3. **This increase brings the A1 grade to a minimum wage of USD260.00**
4. Parties further agreed that the minimum wages for the period 1 June 2023 to 31st August 2023 be paid as follows:
  - 4.1. That 50% of each grade minimum wage be paid in United States Dollars (USD).
  - 4.2. That the other 50% of each grade minimum wage be paid in ZWL calculated at the prevailing inter-bank rate on the date of company payroll run.
5. All companies shall pay the NEC, Trade Unions, and Employers' associations dues according to the portions stated in points (4.1) and (4.2) above.
6. Further to, parties have agreed that employers paying full wages or in accordance with point 4.1 above shall remit corresponding NEC dues in the United States Dollars (USD), and dues for the wages paid in Zimbabwean dollars (ZWL) portion shall be paid at the prevailing inter-bank rate as at the date of payment to the NEC.
7. Every employer shall, therefore, with effect from 1<sup>st</sup> June 2023, pay each employee a wage/salary not less than the appropriate amounts as specified for each grade or class in Annexure 'A' of this agreement.
8. This wage agreement shall subsist subject to review by the parties to the Collective Bargaining Agreement.
9. Nothing contained in this agreement shall preclude companies from negotiating betterment of the agreed wage levels and any other working conditions at company works councils.
